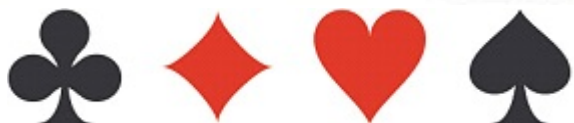

THE OREGON TRAIL (The Great Migration, from the DVD "The Oregon Trail")

Despite enthusiasm stirred up by early pioneers, few people made the trip because they feared the Rocky Mountains. In 1843, government explorer John Fremont thrilled the nation when he described how easily a wagon could make it through South Pass. The big move West was about to begin. That spring, nearly a thousand people gathered near Independence, Missouri, intending to form the first wagon train to travel all the way to Oregon's Willamette Valley. The whole country was watching, and skeptics abounded. Perhaps the most vehement was Horace Greely, editor of the N.Y. Daily Tribune. But that wagon train *did* make it to Oregon, and over the next 30 years nearly 100,000 more men, women, and children would follow the ruts West.
