## CALL TO ORDER

## **OLD BUSINESS**

Locations for Sectionals:

- Because the Kliever Armory will be closed for roof repair, we cannot hold our September 18-20 Sectional there. We have been offered the Clackamas Armory instead for the same \$1800 rental cost as Kliever, even that is well below the usual cost at Clackamas. George volunteered to visit the Clackamas Armory and evaluate its suitability.
- We have been told that decontamination has taken place at Kliever and there is almost no lead risk. We discussed alternatives such as hiring our own experts to conduct a test but agreed first we will ask Kliever for documentation of the present status.
- George will head a new committee to consider other locations for Sectionals. He will ask Inez Weiss to join the committee. Among the location requirements are 5000+ square feet (7000-8000 preferred), good lighting, chairs, parking, and the ability to guarantee dates a year in advance.

Portland Spring Sectional (May 29-31 at Kliever Armory):

- Alan distributed the attendance and financial details for the tournament. The bottom lines were 237.5 tables and a profit of \$513.81.
- Sunway sandwiches were a popular choice between sessions of Sunday Swiss.
- Given the congestion near the registration table, it was agreed we may want to position the partnership table further away.

<u>Starting times at Sectionals</u>: At our last five Sectionals our Saturday starting times have been 10:30 and 3:30, compared to the previous noon and 5:30. Those Sectionals have had lower Sunday attendance than previously, which raises the question of whether the Saturday times are a factor. We will address whether to try going back to the later Saturday starting times for our 2016 Sectionals.

<u>New Unit directory</u>: Amy is making good progress. She picked up changes that members have written on the lists that we made available at the clubs.

<u>Storage facility for Unit supplies</u>: It was agreed to defer any further search for a storage facility until we resolve whether we'll be moving our Sectionals from Kliever to somewhere else.
